## Through the Gears

**First gear:** If there was any doubt the 2020 Cup Series is a two-man race, look no further than last week's race at Kansas Speedway. Denny Hamlin took the checkers and now leads the series in wins (five) and playoff points (28), edging ahead of Kevin Harvick, who has four victories and leads the overall points standings. Hamlin passed Harvick for the lead with 14 laps to go, making that win all the more sweeter. "Harvick got loose there, and when you get in clean air, I think it was probably the first time he was in clean air all day," said Hamlin, who emerged from a rough patch of finishes. "I saw him get loose and I saw kind of blood in the water there, so we just ran him down." Harvick, 44, is having one of his best seasons and running his No. 4 Ford with swagger. He finished fourth at Kansas.

**Second gear:** NASCAR ran four Cup Series races before the coronavirus shut everything down in March. Since racing resumed May 17 at Darlington Raceway, the series has staged in 15 points races and the All-Star Race. Competitors have run back-to-back races at Darlington, Charlotte Motor Speedway and Pocono Raceway to sync up to its original schedule head-

ing into the playoffs. In Pocono's case, those races were held on consecutive days in order to help accommodate NBC and its planned Summer Olympics coverage. The Olympics were postponed to next year. This is a quiet week. There is only one NASCAR race this weekend, The Foxwood's Resort Casino 301 at New Hampshire. Exhale.

**Third gear:** Ryan Preece is having a bad run of luck that actually transcends bad luck. In his last four starts, he has finished last three times and has been involved in three wrecks. His crash at Kansas looked horrifying, but he escaped unscathed. "It's frustrating for all of us at JTG Daugherty because we've been working really hard and probably had a top-10 car there at the end," he said after emerging from the care center. "I'm all right, just ready for this year to turn around."

**Fourth gear:** Two passings to note. Master motor builder Maurice Petty, 81, the brother of Richard Petty, died Saturday. Maurice built the crazy horsepower engines that Richard enjoyed during his heyday in NASCAR. A few days earlier, Bob Bahre, who founded New Hampshire Motor Speedway, died at 93.

# Where you can shop tax-free

## 10 states with sales tax holidays this weekend

Shoppers in 10 states should file this away: This weekend, you can pick up clothes and school supplies tax-free.

Sales tax holidays kick off Friday in nine states – Florida, Iowa, Missouri, New Mexico, Ohio, Oklahoma, South Carolina, Texas and Virginia – and Maryland's tax holiday begins Sunday. Alabama, Arkansas, Mississippi and Tennessee already held their tax holidays. Maryland and Connecticut will offer tax breaks later in August.

The back-to-school shopping season, the second-biggest period for retailers, behind the holidays, usually kicks off in mid-July and peaks in mid-August. This year, it's off to a slow start amid the COVID-19 pandemic. Experts predict the shopping season will peak in late August and spill into most of September.

The purchases parents are making are different than in previous years. Clothing is less of a priority, replaced by electronics, face masks and other protective equipment. Computers are tax-free this weekend in four states: Florida, Missouri, New Mexico and South Carolina under different thresholds.

According to the National Retail Federation, parents with children in elementary school through high school plan to spend an average of \$789.49 per family, up from \$696.70 last year. That spending is expected to total \$33.9 billion, up from \$26.2 billion last year, breaking the record of \$30.3 billion set in 2012.

The trade group predicts that college students and their families will spend a total of \$67.7 billion, up from \$54.5 billion last year.

# Twitter to label officials' government accounts

Twitter has created labels for profiles belonging to government officials and state-run media entities to ensure that political reach is "earned not bought."

The social networking platform said in a blog post Thursday that the labels are meant to give users greater context regarding a profile's political affiliation.

"We believe this is an important step so that when people see an account discussing geopolitical issues from another country, they have context on its national affiliation and are better informed about who they represent," Twitter said.

The new feature comes in the form of a gray icon and wording on the user's profile. Twitter will start by focusing on senior political officials who speak for their states. This includes foreign ministers, ambassadors, official spokespeople and key diplomatic leaders.

Accounts belonging to state-backed media organizations along with related editors and senior staffers will also be labeled.

"Unlike independent media, state-affiliated media frequently use their news coverage as a means to advance a political agenda," the platform said. "We believe that people have the right to know when a media account is affiliated directly or indirectly with a state actor."

The move by the social networking website was deemed a step in the right direction by Rep. Alexandria Ocasio-Cortez, D-N.Y.

"I appreciate that Twitter is a platform that's at least \*trying\* to stop disinformation, verifying news outlets, etc. Stopping misinformation isn't about sitting around for years debating ideas. It's about testing tactics, trying ideas, etc to find what's effective," Ocasio-Cortez tweeted.

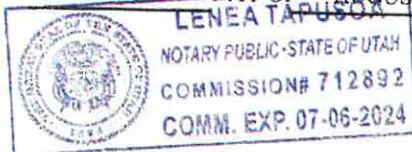
