



10 states with sales tax holidays this weekend

Shoppers in 10 states should file this away: This weekend, you can pick up clothes and school supplies tax-free.

Sales tax holidays kick off Friday in nine states - Florida, Iowa, Missouri, New Mexico, Ohio, Oklahoma, South Carolina, Texas and Virginia - and Maryland's tax holiday begins Sunday. Alabama, Arkansas, Mississippi and Tennessee already held their tax holidays. Maryland and Connecticut will offer tax breaks later in August.

back-to-school shopping season, the second-biggest period for retailers, behind the holidays, usually kicks off in mid-July and peaks in mid-August. This year, it's off to a slow start amid the COVID-19 pandemic. Experts predict the shopping season will peak in late August and spill into most of September.

The purchases parents are making are different than in previous years. Clothing is less of a priority, replaced by electronics, face masks and other protective equipment. Computers are tax-free this weekend in four states: Florida, Missouri, New Mexico and South Carolina under different thresh-

According to the National Retail Federation, parents with children in elementary school through high school plan to spend an average of \$789.49 per family, up from \$696.70 last year. That spending is expected to total \$33.9 billion, up from \$26.2 billion last year, breaking the record of \$30.3 billion set

The trade group predicts that college students and their families will spend a total of \$67.7 billion, up from \$54.5 billion last year.

Twitter to label officials' government accounts

Twitter has created labels for profiles belonging to government officials and state-run media entities to ensure that political reach is "earned not bought."

The social networking platform said in a blog post Thursday that the labels are meant to give users greater context regarding a profile's political affiliation.

"We believe this is an important step so that when people see an account discussing geopolitical issues from another country, they have context on its national affiliation and are better informed about who they represent," Twitter said.

The new feature comes in the form of a gray icon and wording on the user's profile. Twitter will start by focusing on senior political officials who speak for their states. This includes foreign ministers, ambassadors, official spokespeople and key diplomatic leaders.

Accounts belonging to statebacked media organizations along with related editors and senior staffers will also be labeled.

"Unlike independent media, stateaffiliated media frequently use their news coverage as a means to advance a political agenda," the platform said. "We believe that people have the right to know when a media account is affiliated directly or indirectly with a state

The move by the social networking website was deemed a step in the right direction by Rep. Alexandria Ocasio-Cortez, D-N.Y.

"I appreciate that Twitter is a platform that's at least *trying* to stop disinformation, verifying news outlets, etc. Stopping misinformation isn't abt sitting around for years debating ideas. It's about testing tactics, trying ideas, etc to find what's effective," Ocasio-Cortez tweeted.


