It is up to the vendor to determine what pricing method they wish to submit. The only restrictions on pricing are that it must be auditable (i.e. the customer can compare their invoice to the pricing submitted and determine that they received the contract price) and cost-plus is not allowed. If freight is going to be charged under this contract, it must be priced. Vendors are reminded that prices are not-to-exceed.
