Just to confirm . . . Our high-impact tutoring program uses district/school curriculum, Hello-- • benchmark and other assessments, and (often, unused) ancillary grade-level materials to ensure best possible alignment between tutoring and grade-level content/learning objectives, track measurable progress, and save districts money. Is the district/school able to provide their curricular resources to make certain tutoring sessions extend the classroom and connect learning? • vendor does not provide test prep, can they still respond to the other requirements of in-person tutoring that are listed in the RFP? Otherwise, test prep could be provided if the district or LEA provided test prep materials. Would this second solution be acceptable? • While our tutors comply with district directives for individualizing tutoring sessions and learning methods for any student with an IEP/504 plan, they are not part of a student's IEP/learning services team and thus cannot demonstrate measurable progress on IEP goals through tutoring sessions. Is this understanding acceptable to Region 10? • Will Region 10 be responsible for setting up program guidance and parameters for their districts and/or schools (i.e., overall scheduling hours, establishing school-level point person, issuing POs, etc.)? In other words, will Region 10 be involved in centralized decision-making for implementation efficiency and timeliness? Or will each district or school determine its own implementation structure, scheduling, timeline, budget, etc. and issue its own POs for services? • Since the Tutoring Solutions Center of Excellence at Kelly Education is already a vetted and approved tutoring vendor for use by Region 10 districts and schools through TEA's Vetted Texas Tutor Corps, how does this RFP differ from our application process through the Tutor Corps? Thank you!

1. That will be up to the individual Equalis member to determine. However, it is a safe assumption that most agencies will provide the relevant classroom resources to vendors. 2. Yes, vendors may respond to part or all of the scope. 3. It is up to vendors to be able to demonstrate their capabilities and effectiveness in their response to this RFP. Potential progress benchmarks for individual Equalis members will be negotiated between the vendor and the member. 4. No. Region 10 ESC is



providing a purchasing vehicle for the national Equalis membership, but Region 10 ESC will not provide any program decision-making for members who choose to utilize this contract. 5. This is a formal bid process that enables agencies across the United States to piggyback on Region 10's procurement process for the scope of services listed. It will assist agencies in purchasing the services listed in the scope of work without having to go out to bid themselves, as this process is compliant with state and federal procurement statutes across the country.
