



## **Pac-12 teams steal spotlight** with Notre Dame thrown in

By the time Saturday's college football action is completed, half the season will officially be in the books. The Week 7 schedule features four matchups of Top 25 teams, as well as a fifth one that perhaps should be. Most of the top contests involve programs from the western half of the country, but naturally the southeastern quadrant will see its share of action as well.

Sharp-eyed readers will note the lack of entries on this list from the day's lackluster noon ET window. We therefore recommend if the weather is nice where you are this might be a good week to go apple picking or engage in some other form of outdoor fun before the midafternoon kickoffs.

Here's our list of the best seven games to take in this week.

#### No. 8 Oregon at No. 6 Washington

#### Time/TV: 3:30 p.m. EDT, ABC

Why watch: The game of the week goes down in the future Big Ten hotbed that is the Pacific Northwest. But never mind all that now - let's just enjoy this last ride through the Pac-12 as its two most complete College Football Playoff contenders square off. The contest features two of the nation's three most productive scoring offenses, but both programs know how to play some defense as well. Huskies QB Michael Penix Jr. is averaging a ridiculous 11.2 yards per pass attempt, with WRs Rome Odunze and Ja'Lynn Polk stretching the field. Ducks QB Bo Nix and WR Troy Franklin are equally capable of connecting for explosive plays at any time, but RBs Bucky Irving and Jordan James are just as dangerous when ball control is needed. Names you're likely to hear a lot on the defensive side include Oregon DE Jordan Birch and Washington DB Dominique Hampton.

Why it could disappoint: It's hard to imagine it could. Both teams have sufficient fire power to mount a rally and neither offense is prone to giving the ball away. We'll be surprised if this one doesn't come down to the wire.

#### No. 22 UCLA at No. 14 Oregon State

#### Time/TV: 8 p.m. EDT, Fox

Why watch: It might be considered the undercard in the Pac-12 this week, but it's every bit as important as the big showdown in Seattle as these potential challengers attempt to avert a second league loss and stay in the championship mix. Amid all the storylines around the league over the first month, the vast improvement of the UCLA defense has been somewhat overshadowed. LB Darius Muasau and his fellow Bruins now turn their attention to keeping Beavers QB D.J. Uiagalelei and RB Damien Martinez contained. The Oregon State stoppers, anchored by LB Easton Mascarenas-Arnold, will look to stifle the ongoing development of UCLA freshman QB Dante Moore. Why it could disappoint: The offenses here aren't quite as flashy as those on display in Seattle, so it might not be quite as entertaining. It should, however, feature its share of pivotal moments. It's possible one team could pull away with a major momentum swing, but it's more likely it will be competitive in the fourth

Bertrand if he is again forced to scramble. Irish QB Sam Hartman will be happy to have the city of Louisville in his rearview mirror, but he must still beware of takeaway threats like USC DBs Jacobe Covington and Calen Bullock.

Why it could disappoint: There are a couple of possibilities. The Trojans' aerial attack could break out of its mini slump and explode, or the Irish offensive line that got pushed around last week at Louisville could find the matchup with the USC front much more to its liking. The first few series should tell us which scenario is more likely.

#### No. 25 Missouri at No. 23 Kentucky

#### Time/TV: 7:30 p.m. EDT, SECN

Why watch: Life in the SEC is never easy. Both these programs trying to break through with signature wins found that out the hard way last week and now look to bounce back. The Wildcats had any notions of an upset squelched early at Georgia, while the Tigers might have a harder time putting the missed opportunity at home against LSU behind them. Kentucky's first order of business will be reestablishing the line of scrimmage for standout RB Ray Davis, who was largely stymied by the Bulldogs with little aerial support from QB Devin Leary. QB Brady Cook will once again look for WR Luther Burden III early and often. Why it could disappoint: Theoretically Missouri has the big-play capability to stage a comeback if needed,

Moving the chains was not the issue for Miami against Georgia Tech, but the recurrence of QB Tyler Van Dyke's bad habit of putting the ball in harm's way is a major concern. Disruptors like UNC LB Cedric Gray will do their best to induce more miscues. Tar Heels QB Drake Maye, meanwhile, has the ground game in high gear with help from RBs Omarion Hampton and British Brooks. Miami LB Francisco Mauigoa will lead the effort to keep them bottled up. Tennessee has a rest advantage, having dominated South Carolina in its most recent action two weeks ago. QB Joe Milton and RB Jaylen Wright might not find the going guite as easy against LB Edgerrin Cooper and the Aggies' front, but A&M must reenergize quickly after last week's battle with Alabama. "Killers" is adapted from David Grann's 2017 nonfiction book, which traces how the federal investigation into the Osage murders led to the birth of the FBI. DiCaprio initially was cast as lead investigator Tom White (now played by Jesse Plemons), who was the central protagonist in early drafts of the script. But at DiCaprio's suggestion, Scorsese and co-writer Eric Roth shifted the focus to Mollie and Ernest, in an effort to put the Osage Nation front and center.

Ernest is encouraged by his twofaced uncle, William Hale (Robert De Niro), to marry into Mollie's wealthy family. The self-proclaimed "King of the Osage Hills," Hale was well-known for his generous contributions to the Osage community. But he later was convicted of murdering his friend, an Osage man named Henry Roan (William Belleau), on whom he had taken out a \$25,000 life insurance policy.

"I don't get how he can make that dichotomy in his thinking," Scorsese says of Hale's actions. "And yet, if he could do it, that means that in our own human nature, anyone could do it. And that's the fear: that maybe we're all capable of this sort of thing."

#### 'This doesn't happen in Hollywood, ever'

Despite Scorsese's Oscar-winning pedigree ("The Departed"), his desire to tell this story was met with understandable trepidation from the Osage people. After all, he's a white director best known for mob dramas including "Goodfellas" and "Casino."

"We love your movies, but we're concerned that in your movie, we're all just going to be dead bodies," Geoffrey Standing Bear, principal chief of the Osage Nation, recalls telling him. "We were concerned that the violence would just show us as backdrop."

"It's very sensitive for our Osage people," adds Chad Renfro, a consulting producer and Osage ambassador. 'When I was growing up, our elders always said, 'We don't talk about that.' It was so extraordinarily traumatic."

To help reassure them, Scorsese sent Standing Bear a DVD of his 2016 movie "Silence," which follows 17th-century Portuguese Jesuits facing persecution. The Gray Horse Osage community also hosted a dinner for the director to hear the concerns of tribal members, many of whom had relatives who were murdered during the five-year period known as the Reign of Terror.

Johnny Williams, who was an elder in the Gray Horse community, was on set every day overseeing a lot of the things that were culturally sensitive," Renfro says. "Chief Standing Bear put together a list of consultants to make

who added more Osage-language dialogue throughout, in part because the actors loved speaking it. For everyone, "it was a process of discovery."

For Native American actors, it was a "once-in-a-lifetime experience," says Welana Fields Queton, a board member for the Osage Nation Foundation who acted as a background extra. Among the top-grossing 1,600 movies of the last 16 years, only one had a Native lead character (2020's "The New Mutants"), according to a new study by the Annenberg Inclusion Initiative.

Working on this film, "everyone on set was Native, so all we did was joke and talk about Native things. That was beautiful. This doesn't happen in Hollywood, ever," Queton says. "Scorsese is opening the avenue for the proper way to come into a community: by going through our leaders and our elders."

#### 'Give the same respect to cinema'

With its grave subject matter, R rating and 3½-hour running time, the critically acclaimed "Flower Moon" faces a steep uphill battle at the box office, compounded by its reported \$200 million budget. The film's stars have been unable to promote the project due to the ongoing actors' strike, although it's still expected to win the weekend with a \$30 million opening, says Shawn Robbins, chief analyst at Box Office Pro.

"This is the kind of adult-driven prestige film that has considerable upside at the box office in today's world," Robbins says. "DiCaprio and Scorsese have one of the most critically and commercially fruitful histories of any star-director duo," with past hits including "Shutter Island" and "The Wolf of Wall Street."

That film, coupled with the success of "Barbie," proved "that people will go out to have an experience in a theater together," Scorsese says. "I hope that follows through with 'Killers of the Flower Moon.' People say, 'Well, there's length.' You do this in front of your television for five hours. You go to a theater and watch a play that's 3 hours and 20 minutes, and you're respectful. Give the same respect to cinema."

#### 'What do we do, not talk about it?'

Regardless of its awards or box-office haul, Renfro hopes that "Flower Moon" will help give Native talent more opportunities in front of and behind the camera.

"One of the best things that can come from this film and this atrocity and uncovering it is for Native representation to grow," Renfro says. "We haven't had a chance to shine like this many times before."

Nonetheless, the film has stirred complex feelings in the Osage community. Christopher Cote, an Osage language consultant on the project, gave a measured critique to The Hollywood Reporter, saying that the film is told from Ernest's perspective and "isn't made for an Osage audience."

"I would agree," Queton says. "There is a bigger part of the story of who we are as Osage. I know Scorsese did his best in trying to give a little background ... But we have a large history before (the Reign of Terror), and I hope other people take interest in that and learn about us."

Still, Scorsese hopes that "Flower Moon" can bring awareness to a brutal yet "important" part of American history that many audiences may just be learning about.

"I'm 80 now, and I kept thinking, 'Well, everybody should know that; everybody should know this.' There are people who don't even know about World War II," Scorsese says. "So what do we do, not talk about it? Let's show it. Let's talk about it. Because it's happening again; look at what's happening around the world.

acters and contemporary topics.

Among the season's episodes: "Edith's Christmas Story," about Edith Bunker's breast cancer scare, and "Lionel's Engagement," which introduced on "Family" Lionel Jefferson's interracial soon-to-be-in-laws; "George," about by-the-book "M\*A\*S\*H" Major Frank Burns' attempt to have a gay soldier dishonorably discharged; "The Lars Affair," which introduced Betty White as Happy Homemaker Sue Ann Nivens; and writer Treva Silverman's double-Emmy-winning "The Lou and Edie Story," about the beginning of the end for newsroom boss Lou Grant's marriage on "Mary."

The season also marked the first appearance on "Carol Burnett" of "The Family," a sketch about a dysfunctional Southern family that became the series' most popular recurring bit.

By the end of the 1973-74 season, all four sitcoms ranked among TV's Top 15 shows.

At that year's Emmys, the threehour block cleaned up. Three of the four Saturday sitcoms were among the five nominees for best comedy, and all nine nominees in the comedy supporting actor and actress categories came from the quartet, as did all the nominees for comedy writing and directing.

Final Emmy tally for CBS from the Saturday lineup alone: 12 wins, and 29 nominations. Except for one award, every comedy-series Emmy at the 1974 awards went to a CBS Saturday show.

Through the years, other lineups have rivaled the famed CBS block. Chief among them was ABC's 1977-78 Tuesday ("Happy Days," "Laverne & Shirley," "Three's Company," "Soap," and "Family"), but ABC's night didn't offer the same prestige factor. Others that did, such as NBC's 1984-85 Thursday ("The Cosby Show," "Family Ties," "Cheers," "Night Court," "Hill Street Blues"), and its must-see-TV Thursdays in the 1990s came up short.

The greatest night in television history lasted just one season. The following year, CBS moved "M\*A\*S\*H" to Tuesdays, which helped that night but did little for Saturday, where it was replaced by the short-lived "Paul Sand in Friends & Lovers." Saturdays on CBS never fully recovered, and by the mid-1990s the network got out of the comedy business altogether on the night.

Today, on a vastly different television landscape, the idea of assembling nightlong blocks of programming - if not the concept of TV scheduling in general – is almost quaint. But for TV aficionados, the 1973-74 CBS Saturday schedule is remembered as what TV Insider labeled "history-made" in 2017.
