

In 2015, the Texas Legislature adopted House Bill 1295, which added section 2252.908 of the Government Code. The governmental entity or state agency must notify the commission, using the commission's filing application, of the receipt of the filed Form 1295 with the certification of filing not later than the 30th day after the date the contract binds all parties to the contract. 
