

AMENDMENT 1 TO EQUALIS GROUP MASTER AGREEMENT

This first Amendment (this "**Amendment 1**") to the Equalis Group Master Agreement (the "**Agreement**") is made and entered into as of the October 22, 2024 (the "**Amendment 1 Effective Date**"), by and between The Cooperative Council of Governments ("**CCOG**"), Equalis Group, LLC ("**Equalis Group**"), and Musco Sports Lighting, LLC ("**Musco**").

RECITALS

- A. The Parties hereto entered into that certain Equalis Group Master Agreement, dated as of November 1, 2020, and the Parties desire to amend the Agreement, on the terms and conditions as provided herein.
- B. The Parties hereto agree that the Agreement is amended as stated herein and that this Amendment shall be incorporated into the Agreement and made a part thereof.

NOW, THEREFORE, in consideration of the mutual covenants set forth herein, the Parties agree as follows:

- 1. Add the following subsection to the Master Agreement under Section 2 Business Terms.
 - 2.6. Geographic Availability.** Musco agrees to make the Products and Services available in all fifty (50) states, the District of Columbia, and all United States territories.
- 2. This Amendment 1 will materially impact the response and information provided in Musco's Technical Proposals including but not limited to the response to Question 3.3.3. Geographic Reach.
- 3. Capitalized terms not otherwise defined in this Amendment 1 shall have the same meaning as set forth in the Agreement. This Amendment 1 may be executed in any number of multiple counterparts, each of which shall be deemed an original, but all of which together constitute one and the same instrument. Scanned original signatures will be considered original signatures. Any provision not specifically modified by this Amendment 1 shall remain in full force and effect.
