



David Skinns sets record with 60

About the only putt David Skinns missed all day was his penultimate one.

Skinns, who was a birdie away from becoming the third PGA Tour player to shoot 59 in 2024, had 9 feet for yet another circle on his final hole during the opening round of the 2024 Sanderson Farms Championship.

The putt started at the right edge of the cup, and on the pristine greens of The Country Club of Jackson started breaking left, but it didn't stop. The putt missed just left of the hole, and with that missed his chance at adding his name to an exclusive club in professional golf.

"It's hard not to be a little bit disappointed because how many 9-footers are you going to get to shoot 59?" Skinns said. "I'm sure I'm not going to get many. Tough not to be a little bit disappointed, but I really want to just look back on how kind of in control mentally I felt, how I kept attacking. Wasn't really thinking about the future at all, which is kind of the thing I'm going to take away

All is not lost for Skinns, however. The 42-year-old from England shot 12-under 60 on Thursday during the opening round of the Sanderson Farms, setting a course record with a stellar performance approaching the greens and on the putting surfaces. As poor as he was off the tee (Skinns hit only five of 14 fairways), he gained nearly five strokes on the field approaching the green, and once he got on the putting surfaces, he hardly missed any, gaining nearly four strokes while making 134 feet of putts on only 21 putts.

Skinns made twice as many birdies (12) as he did pars Thursday, and he holds a three-shot lead over PGA Tour rookie Michael Thorbjornsen after the morning wave. He said soft greens and light winds helped contribute to the numerous low scores from the morning wave, but Skinns' score stands above them all.

He started on the back nine and birdied his first two holes. After a pair of pars, he proceeded to birdie four straight before making the turn in 6-under 30. Once on

the front nine, he had another string of four consecutive circles from Nos. 2-5 and added two more on Nos. 7-8.

Then came the miss on the closing par-4 ninth. Nevertheless, it's a 60 for Skinns, who remains searching for his first PGA Tour victory.

"A bit of a dream, really," Skinns said of his stellar performance. "Those are the ones that you turn around and you're 7 under, you're like, 'Wow, I didn't feel like I did too much."

Skinns' season has had its ups and downs. He has a T-4 at The Cognizant Classic and a T-7 at the Texas Children's Houston Open, but he also has missed 10 cuts in 21 starts. Coming into the Sanderson Farms, he missed the weekend in three of his past five starts.

Devils, Sabres seek start of revival in Prague

The 2023-24 season was one of disappointment for both the New Jersey Devils and Buffalo Sabres.

However, after an offseason with notable change for each, the two teams look to kick off the 2024-25 campaign in a positive manner when they face off Friday in Prague, Czech Republic, for the first of two games in the 2024 NHL Global Series Czechia.

The Devils finished 23rd in the NHL last season with 81 points, a stark drop-off after logging 112 points and finishing third in 2022-23. That season they had a 16-3-0 start, including a 13-game winning streak, and made the playoffs for the second time in 11 years.

"A good start for us is imperative," New Jersey general manager Tom Fitzgerald told NHL.com. "Those 13 games helped soften the blow for the losing stretch (in December, 1-7-1) because you're still playing with house money.'

Sheldon Keefe was hired to replace interim head coach Travis Green, who stepped in after Lindy Ruff was fired on March 4.

Ruff, meanwhile, is now behind the bench for the Sabres, charged with guiding them to the playoffs for the first time since 2011, when he was the last Buffalo coach to do so.

After years of seemingly endless rebuilds, hope sprang when Buffalo finished a point behind the Florida Panthers for the second Eastern Conference wild card in 2022-23. An inconsistent 2023-24 campaign resulted in a seven-point drop, extending the postsea-

son drought to an NHL-record 13 seasons. GM Kevyn Adams acquired Ryan McLeod from the Edmonton Oilers for highly touted prospect Matt Savoie. He traded for Beck Malenstyn and signed Jason Zucker, Sam Lafferty and Nicolas Aube-Kubel.

Rasmus Dahlin was named captain on Sept. 26.

Reeves, Bullock reunite with 'Speed' director to talk surviving the crashes

LOS ANGELES – For one night only, the "Speed" bus rolled again.

More than 30 years after the release of the classic 1994 action thriller, stars Keanu Reeves, Sandra Bullock and director Jan de Bont reunited for a raucous "Speed" screening and the first group discussion on Tuesday. Hundreds of fans waited in vain to get into the sold-out Beyond Fest at the American Cinematheque event, which featured boisterous cheers during every "Speed" action moment.

"We knew we were doing something wacky," Reeves, 60, said of making the movie in which he portrays a police officer trying to prevent a bomb from exploding on a city bus - driven by a passenger named Annie (Bullock) - by keeping the speed above 50 mph.

Bullock, 60, who had a break-out performance in "Speed," said she was too inexperienced to know that actually driving the movie's bus (she received a Santa Monica bus driver's license) and smashing into cars was not a normal filmmaking experience ("Speed" went through 14 buses).

"I was at the wheel of projectile. So I was just happy to be alive," said Bullock. "I was new to the whole game, so I wasn't aware of what was happening or what felt right. We were just in it. It was real. When we were smashing into things (on screen), we were really smashing into those things."

Bullock said she fought hard for the role she loved.

"But other people turned (the role) down, there were other people ahead of me," Bullock said as the director protested.

"When I saw you, I knew it was going to be you," de Bont, 80, said.

"But you saw me after one, two, and three couldn't do it," Bullock said, laugh-

During a discussion about the realistic "Speed" stunts, Bullock had a casting epiphany.

"It just dawned on me why you want-

ed me in the role," said Bullock. "If you killed me, I wasn't a big actor at the time. It would have been 'Actor dies in stunt making Keanu Reeves movie.''

"Point Break" Reeves was already an enigmatic Hollywood star leading "Speed" who had his first film meetings with long hair. Reeves then reappeared for the "Speed" shoot with a closeshaved "sniper" haircut without advance notice. This was a big deal for the leading man that sent shockwaves through the set.

"I heard these whispers, 'He's cut his hair. Why did he cut his hair? His hair is too short!' I just felt this pervading feeling. It was like, 'It's too late, man!' ' Reeves recalled.

De Bont said he came to love the hair-

cut after he got over the surprise.

"Actually, once you had the short haircut, you actually became the character. And that was so fantastic," he said to Reeves. "I didn't want you to grow the hair; you would look too relaxed. I wanted you more tense."

Reeves performed most of the intense practical stunts in "Speed," including the famous scene in which his character lies in a cart attached to a cable and is rolled under the moving bus to defuse the bomb.

"When I was under the bus with that little cart thing with the little wheels, and you're going 25 to 30 mph, that gets a little sketchy," said Reeves. "Then they were like, 'Let's put another wire on it.' It became a thing.

Then they were like, 'Maybe we don't put Keanu in that anymore.'

Will there be a 'Speed 3'?

Naturally, the discussion turned to a new film. Reeves sat out of the critically derided 1997 sequel "Speed 2: Cruise Control" which featured Jason Patrick, Bullock and de Bont directing.

Would the trio consider "Speed 3" three decades later?

"The geriatric version," Bullock said comically. "It won't be fast."

"Speed 3: Retirement," Reeves added. "It would be a different movie for sure," said de Bont. "But it would be great to work with them both. That's absolutely true."

DeBose enjoyed the challenge of horror film 'House of Spoils'

NEW YORK - Academy Award winner Ariana DeBose admits that when it comes to movies, she prefers "cupcakes, sprinkles and joy." None of those are found in her latest film, "House of Spoils" (streaming now on Prime Video). The horror movie brings the star into unfamiliar territory.

"I do think that horror can sometimes allow you to process through fear," De-Bose, 33, tells USA TODAY. "I think there are people who like to feel scared. I'm not one of them."

The actress says she respects the genre and enjoyed the challenge that "House of Spoils" provided.

'Making this particular film actually showed me that there's a technique" to horror, she explains. "It does take real skill. It's not just, 'Oh, my gosh, I'm going to scream my face off."

DeBose took the role of a lead seriously and was cognizant of how she carried herself on the set. Past experiences, both positive and negative, informed her actions. DeBose wouldn't divulge any names of colleagues who left a bad impression, joking that she wants "to work again." When it comes to positive experiences, she immediately mentions "West Side Story" co-star Rita Moreno and Jamie Lee Curtis.

"The vibe that I get from her, even

when she's just cultivating relationships within the industry, it's joy. It's curiosity. It's genuine," DeBose says of Curtis. "Like, wanting to know, what's your vibe? What do you think?"

'House of Spoils' serves up horror with a side du jour

DeBose had to sharpen her knife skills for "House of Spoils," but this isn't a slasher film. The actress plays a chef who leaves a fancy New York City restaurant to run a trendy new spot upstate. There are a number of issues, namely a less-than-savory restaurateur (Arian Moaved) who also thrusts an unqualified sous chef (Barbie Ferreira) upon her. But perhaps most importantly, the place is haunted by its previous owner.

To train for her kitchen scenes, De-Bose visited Chef Ayesha Nurdjaja at Shukette, a Middle Eastern restaurant in Manhattan's Chelsea neighborhood. She says the experience was "enlighten-

"Just seeing how the energy of a kitchen functions and like every chef in the kitchen needs each other," she recalls. "But also it all revolves around the head chef and everyone has their own leadership style. So I took a lot of different things from Chef Ayesha and I chopped a bunch of vegetables every day while I was making this movie."

Is a return to Broadway next for DeBose?

DeBose will soon head to Nashville to film another Prime Video project: the recently green-lit "Scarpetta" series with Curtis and Nicole Kidman. She's also politically active in a number of campaigns to get out the vote, specifically

for the Democratic Party.

"Not everyone, especially on social media, wants to be in conversation with you," she says. "They want to have an opinion about you or your opinion, and they want to pick it apart, but they don't want to be in conversation about it. And that is a sad thing to me, because I do remember a time growing up where I saw individuals converse about their differences as opposed to shame each other about their differences.

"I'm Puerto Rican, I'm black, I'm queer, I'm a woman. All of these things to me are on the ballot. And I also look at it as when I cast a vote, I'm not just doing it for me, I'm doing it for the people that I love."

In December, DeBose is back in theaters as Marvel's Calypso in "Kraven the Hunter." And as for her seemingly annual gig hosting the Tony Awards, DeBose laughs when the prospect of hosting a fourth consecutive time is broached.

"I doubt it." she responds when asked if she would return to the awards show. "When I have an idea, I come to the table. I love my theater family, but I might be all out of ideas.

"And to be honest, I really want to get back to the stage. I've been very inspired by the things I've seen over the last three years, and it's been a way for me to stay connected (to Broadway), but I also would like to get back to the 'doing.' And so I'm hoping that'll start soon."
