

AMENDMENT 1 TO EQUALIS GROUP MASTER AGREEMENT

This first Amendment (this "**Amendment 1**") to the Equalis Group Master Agreement (the "**Agreement**") is made and entered into as of the June 30, 2025 (the "**Amendment 1 Effective Date**"), by and between The Cooperative Council of Governments ("**CCOG**"), Equalis Group, LLC ("**Equalis Group**"), and Ohio Paving & Construction Co., Inc ("**Ohio Paving**").

RECITALS

- A. The Parties hereto entered into that certain Equalis Group Master Agreement, dated as of Jul 1, 2021, and the Parties desire to amend the Agreement, on the terms and conditions as provided herein.
- B. The Parties hereto agree that the Agreement is amended as stated herein and that this Amendment shall be incorporated into the Agreement and made a part thereof.

NOW, THEREFORE, in consideration of the mutual covenants set forth herein, the Parties agree as follows:

1. **Extension of Contract Term.** By way of this amendment, the Parties agree to extend the Master Agreement through May 31, 2027.
2. **Pricing Adjustments.**
 - a. For the duration of the Agreement, the Adjustment Factors will be updated annually, and new Adjustment Factors will go into effect on July 1.
 - b. For the period July 1, 2025, to June 30, 2026, the following are the Adjustment Factors.
